01. A certificate from the auditors confirming that the paid-up capital of the company is not less than Rs.250,000/-

- 02. A bank guarantee of Rs.500,000/- to cover the validity period of the license.
- 03. a) A copy of the agency agreement signed by the Shipping Agent and the Shipping Line where the Principal operates a regular liner service. (If the shipping agents have already submitted the relevant agreements to the Merchant Shipping Division, a declaration should be made collectively to the effect that the agency agreements remain valid for the relevant year.)
 - b) A letter indicating the agency terms where the principal does not operate a regular liner service. It is recommended to include clauses to cover the following areas.
 - I. Agency Fees will be levied as per CASA Tariff.
 - II. Validity Period of Agency Terms./(Termination Clause).
 - III. Three months notice to be given by the Principal, to the Local Agent in the event of termination of the Agreement.
 - IV. Inward remittances shall be received by the Local Agent, prior to rendering any services and/ or issue outward clearance for a vessel.
 - V. Exclusive Agency / any other agency terms, agreed collectively by the Principal and the Agent.
